# **GENERAL RULES & CONDITION OF ENTRY**

## TRADE STAND APPLICATION FORMS:

- Must be returned by 7<sup>th</sup> February 2026
- Bookings will be accepted on the Society's Trade Stand Application Form only
- Any application for space may not necessarily be accepted
- Allocation of space is at the discretion of the Heytesbury Agricultural Society Inc
- The Heytesbury Agricultural Society reserves the right to relocate any site holder as it deems fit
- A list of the current banned items is attached

# SET UP / PACK UP TIMES:

- Site Holders can set up on the Friday prior to show day. Please contact the Secretary if set up is required prior to that
- Exhibits/Stands must be in place by **9am** on show day and are expected to remain in place until **3pm**
- Site Holders vehicles must be off the grounds by 9am, and not permitted on the grounds again until
   after 3pm
- Site Holders will not be permitted to set up until all paperwork is received and payment made.

#### **SECURITY:**

- Site Holders are responsible for the security of all personal belongings, including commercial stock,
   whist onsite.
- Security will be on the grounds on Friday night prior to the Show

# **SITE HOLDER PASSES:**

- 2 Tickets for entry will be issued for each standard site
- Additional tickets can be purchased for \$8 each (see application form)

#### **FOOD VENDORS:**

Site Holders selling any food or beverage are required to be currently registered under the Food Act
and have in place a Food Safety Program, which covers off-site events. A copy of your current Food
Registration must accompany your Trade Stand Application.

#### HOUSEKEEPING/CLEANING:

• The Site Holder is responsible for the cleaning and condition of their site during and at the close of the Show. Site must be left vacant and in a clean and tidy condition on departure.

#### PUBLIC & PRODUCT LIABILITY INSURANCE:

- Proof (copy) of adequate public risk insurance (minimum \$10m) must be provided when lodging your Trade Stand Application. This is applicable for all ABN registered businesses.
- If you do not have Public Liability Insurance, and are NOT an ABN registered business, an insurance levy of \$30 must be paid with your site fee. Public Liability Insurance cover only will be provided on the understanding that the Site Holder is liable for the first \$1,500 for each and every claim.
- If you do not have Public Liability Insurance, and are an ABN registered business, you can purchase
  public liability insurance from My Market Insurance <a href="https://mymarketinsurance.com.au/">https://mymarketinsurance.com.au/</a>
- Product Liability Insurance: Exhibitors selling or exhibiting goods of any description MUST carry
  product liability insurance including (but not limited to) cover of loss, damage and theft for the
  duration of the Show. Product Liability cover CANNOT be provided by the Show Society insurance
  under any circumstances.
